

## DFCU Parade Of Homes Traeger Contest Rules

**Binding Agreement.** By participating in any DFCU contest you acknowledge that you have read and agree to be bound by these DFCU General Contest Rules (“Contest Rules”). These rules apply to any contest DFCU offers unless more specific contest rules apply.

**Definitions.** As used in these Official Contest Rules, the terms “you” and “your” mean those who enter the contest by completing the steps described in the Contest Materials. “Contest Materials” means the material or media that DFCU uses to announce and market the contest and/or this document.

**Prizes.** The prize is limited specifically to the award described in the Contest Materials which is (1) Traeger TFB29LZA Junior Elite Pellet Grill or model of equivalent or greater value.

**Eligibility.** Any lawful U.S. resident over the age of eighteen (18) who visits the DFCU booth at the St. George Parade of Homes from Feb. 15-24, 2019 is eligible to win. DFCU membership is not required.

**Entry.** Enter to win by attending the St. George Parade of Homes 2019 and completing the electronic survey including your name, phone number and email address in the random drawing. Unless stated specifically in the Contest Materials you may not enter more than once per contest.

**Selection and Announcement of Winners.** Winners will generally be announced and notified within 24 hours of the close of the contest but DFCU reserves the right to announce and notify the winner up to one week after the close of the contest. Winners will be notified through any means available to DFCU and in DFCU’s sole discretion (e.g. telephone, email, Facebook message, etc.)

**Redeeming the Prize.** Within 24 hours after DFCU has notified or attempted to notify a winner, the winner must contact DFCU to work out the pickup of their prize at the nearest DFCU branch within a reasonable timeframe. Prize will not be shipped to winner. If pickup does not occur within a reasonable timeframe or the winner does not contact DFCU then DFCU, in its sole discretion, may select another winner and the original winner will forfeit his/her prize. Each winner will be required to provide valid identification to redeem their prize.

**Odds.** The odds of winning are dependent on the number of entries received.

**Public Disclosure.** Winners may, in the sole discretion of DFCU, be announced publicly through outlets such as, but not limited to, Facebook, YouTube, and Twitter or other media not necessarily related to social media. As a condition to claiming the prize, each winner hereby AUTHORIZES DFCU to continuously use their name and photograph free of charge as well as to publicly disclose such information and, if requested, agrees to sign a separate consent form.

Any attempt by you to improperly influence the selection of a winner will be grounds for your disqualification. not be substituted. No purchase necessary. Void where prohibited. By entering this contest you agree to release Facebook or any other social media outlet of any liability in connection with this contest. Further, you understand that this contest is not sponsored, endorsed, or administered by, nor is it associated with Facebook or any other social media outlet.
